Dear Shareholder,

We are pleased to provide you with the enclosed proxy materials for the CION Investment Corporation (“CION”) 2023 Annual Meeting of Shareholders, which will be held virtually at 5:00 pm ET on Thursday, July 27, 2023 (the “Meeting”). **Your vote is extremely important, regardless of the number of shares you own.** We urge you to vote as soon as possible to ensure that the Meeting can occur as scheduled, which would avoid incurring additional costs to CION and its shareholders.

We urge you to carefully read the enclosed proxy materials, including the proxy statement, as they describe in detail the Proposals (as defined below) to be considered by CION’s shareholders. We are asking shareholders to (1) elect three directors each for a term of three years expiring in 2026; and (2) provide flexibility for CION to sell shares below net asset value in one or more offerings within 12 months after shareholder approval (together, the “Proposals”).

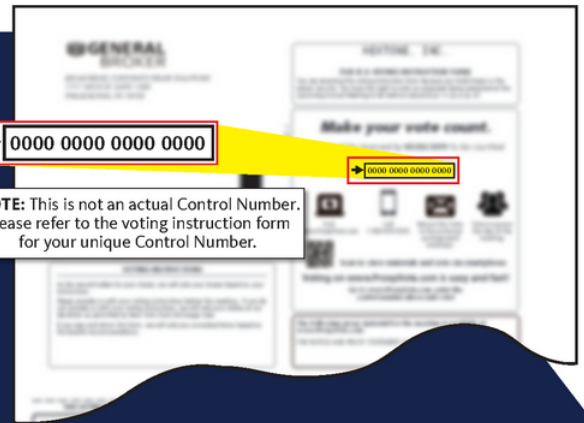
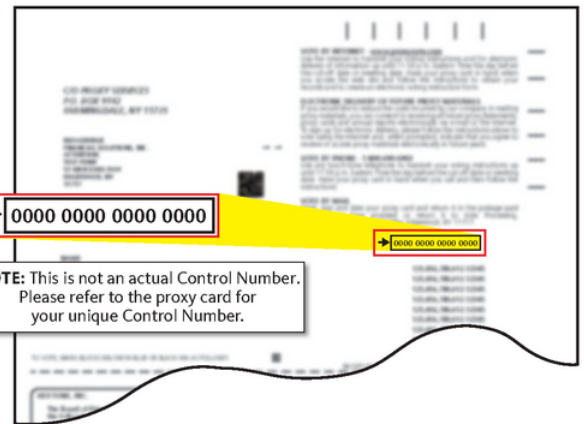
